4. 1st QTR Report – Frost Bank

The market was down last quarter mostly due to trade war rumors between the United States and China The fund is still doin well, we currently have over \$20 million in our account. For a year period, ending April 1, 2018, the fund is up 11.80%, net of fees. The fund is up 7.72% since inception, net of fees.

Our investment policy was re-signed stating that 66% will be invested in stocks, 33% invested in bonds, and 1% in cash, with specific ranges that Frost can use when determining buying/selling stocks & bonds
